<ul> <li>Payments made via payroll deduction and Automated Clearing House will be, if needed, reversed</li> </ul>
from your loan and credited to your savings account.
• If you have a payment set up via Bill Pay or Online Automatic Transfer or ACH, it will be the
member's responsibility to stop the payment (s) and then restart the payment.
<ul> <li>Automatic payments set up internally will be reset to skip the designated payment.</li> </ul>
